on personal data protection of the graduates (bachelor and master of science) from UASVM B

According to EU Regulation 679/2016 on the data of individuals on personal data processing, University of Agronomical Sciences and Veterinary Medicine of Bucharest, 59 Marasti Boulevard, 011464, 1st district, Bucharest, is a data operator.

1. Your personal information collection

University of Agronomical Sciences and Veterinary Medicine of Bucharest collects and uses your personal data in order to fulfil its legal attributions according to law, mainly for the purpose of providing the educational services.

UASVM of Bucharest collects and uses personal data from the next special categories:

- Identity (personal numerical code, documents series and number, etc.);
- Contact (address, e-mail address, telephone, etc.);
- Education (faculty, specialization, domain, etc.);
- Financial (bank account, different payments, etc.).

In this regard you are bound to offer us your personal data in order to realize the goal above mentioned, and your refusal in offering us these data will determine difficulties in organization and providing the educational services.

According to EU Regulation 679/2016, every processing of personal data fulfils one of the following conditions: the concerned person gave its consent for one or more specific goals, it is necessary for execution of a contract in which the concerned person is one of the parts, it is necessary for the operator or a third parts legitimate interest.

3. Categories of personal data recipients

UASVM B may be bound by law to provide certain information to the competent authorities. It exists cases when UASVM B has to transmit information as it follows: name and first name, personal numerical code, identity card series and number, transcript of records, CV, etc. The information could be transmitted to:

- a. National Education Ministry and its subordinate councils;
- b. The Romanian Agency for Quality Assurance in Higher Education;
- c. Healthcare service (CASMB);
- d. Police, Prosecutor's office, Justice Courts, Banks, Local authorities, etc.

4. Protecting collected confidential information

Collected information about you is stored in written and/or electronic form. UASVM of Bucharest assures that the held information is stored in safe locations, with an adequate security level and with authorized access for the designate personal in this regard. Also, UASVM of Bucharest assures that these designate personal is bound by contract to implement technical and organizing measures for data protection, in the case that the processed data identify or could identify a person.

5. Location and storage period

Collected personal data are stored on UASVM of Bucharest servers, located in rooms with an adequate security level and authorized access. Storage period for every personal data categories is in accordance to legal requirements, to UASVM of Bucharest internal regulations and with the best practices in the domain.

6. Legal rights of personal data using

According to EU Regulation 679/2016, you have the following rights:

- a. the right of free access to your personal data processed by UASVM of Bucharest;
- b. the right of data correction or deleting, without violating the legal obligations of UASVM of Bucharest;
- c. the right of processing data restriction or of to oppose your data processing, without violating the legal obligations of UASVM of Bucharest;
- d. the right to withdraw your consent, in any moment, if your personal data processing is based on your consent, without affecting the legality of data processing on the base of your consent before retracting it;
- f. the right of not being subjected to some individual decisions with automatic character;
- g. the right to address to competent justice court.

Disponibility of these rights depends of legal justification of data processing if personal data processing is based on your consent you have the right to withdraw your consent, without affecting the legality of data processing on the base of your consent before retracting it.

According to EU Regulation 679/2016-GDPR, you have the right to file a complaint to the National Authority for Personal Data Processing Survey. More details you can find to <http://www.dataprotection.ro/>. You have the right to request a copy of the information held by UASVM of Bucharest by formulating an access request. In order to request a copy of your data held by UASVM B or to update your information, please contact the Responsible with Data Protection by e-mail: pdcp@usamv.ro. Your request has to contain: name and first name, personal numerical code and home address.

Personal data held by UASVM of Bucharest is subjected to conditions from EU Regulation 679/2016, which offers to the concerned person the access right to all types of registered information, held by the data operator, subjected to certain limitations.
