



Procedure of Graduate Access in the Campus of the Faculty of Veterinary Medicine Study program: Veterinary Medicine (teaching in Romanian and English) In period 23 - 25.06.2020 in order to perform Practical Examination (test 1b) integrated in the Licencing Examination, June 2020,

1. The access of the graduates in the FVM campus, by car or pedestrian, is made EXCLUSIVELY through the **Dr. Staicovici street entrance**, marked with "ACCES CLINICI LICENTĂ MV".

2. The graduates who come with own cars will be using the left-sided parking area from Dr. Staicovici street entrance.

3. The graduates are scheduled for the practical examination in groups of 7-8 persons/ hourly interval (56 graduates / day).

4. The access to the campus will be made hourly, according to the schedule, **starting with 08.00 and ending with 15.00**.

IT IS MANDATORY TO COMPLY WITH THE SCHEDULE. ADMISSION OF STUDENTS INTO THE FACULTY'S CAMPUS WILL BE PERMITTED ACCORDING THE SCHEDULE.

5. Wear of mask is mandatory when the graduates will enter the faculty's campus. They will also present for verification their ID (n.n Identity card, passport, student identification documents). Temperature screening will be also performed..

6. The assignment of discipline in order to perform practical examination will be established by **"drawing lots"** method in the premises on **Clinics Building – Reception area** (Building 14), by accessing the inner courtyard, in the presence of members of Licencing Commission.

7. After discipline-based assignment, the graduates will go DIRECTLY to the examination areas for the practical examination, respectively:

Large Animal Hospital (Building 11) for disciplines:

Reproduction disorders and clinical lectures on species

Infectious diseases, preventive medicine and clinical lectures on species

Internal medicine and clinical lectures on species

Surgery and clinical lectures on species

Parasitology, parasitic diseases and clinical lectures on species

Pathological Anatomy Building / Necropsy Room (Building 6) for the discipline:

Forensic Pathology and Diagnostic Necropsy

Preclinical Sciences (Building 17) for the discipline:

Inspection and control of foodstuff of animal origin

8. The graduates will go through the following stages when enter the practical exam premises:e:

- will store personal belongings in specially designed lockers
- will be equipped with the protective equipment provided by the faculty (surgical mask, footwear protection, single use medical gowns, caps and gloves),
- temperature screening will be performed, as well as fi filling in of *Questionnaire_evaluation and localization on Romanian Territory Chestionarul de evaluare și localizare pe teritoriul României*, according to actual legislation.
- 9. The examination will be done within one hour, starting with the hours 8.30, 9.30, 10.30,

11.30, 12.30, 13.30, 14.30 și 15.30.

10. The distance between persons inside the examination rooms will be kept according to the local marking (2 meters between people); consumption of food and beverages is not allowed within examination areas.

11. It is forbidden to leave the examination room before the end of the activities.

12. At the end of the examination, the graduates will discard the protective equipment (which

will be put in the container indicated by the examiners) and will perform hand sanitation

with soap and water, then with disinfectants.

13. Leaving the campus will be done through gate from Dr. Staicovici Street.

14. It is forbidden to carry out other activities, as well as to travel to other locations on campus.

15. After each hour of examination, the rooms will be properly sanitized.
